ORDER

As per order read above, Board has sanctioned the list of safety materials to be made available at field offices and Director (SCM & Gen. Elec.) has been entrusted with the procurement of safety materials and equipments. The Director (D&S) as per the letter read as 2nd paper above directed all the Deputy Chief Engineers of Electrical Circles to procure necessary safety materials and equipments by the field officers on requirement basis, till the process of empanelment of approved vendors is completed. The requirement of safety materials were furnished to the office of the Deputy Chief Engineer (SCM) with powers of Chief Engineer (SCM) as per the email read as 3rd paper above.

Though safety materials have been arranged by field officers, its price and quality are not uniform even within an Electrical Circle. During the Safe KSEBL committee meeting held on 03.10.2015, the CMD has directed to entrust SCM for the identification and empanelment of vendors and fixing of rate of safety materials and equipments so that field officers can purchase quality materials directly within their purchase limit at uniform rate.

Having considered the recommendation of Chief Engineer (CAPS & Safety) as per note read above, the Full Time Directors in the meeting held on 22.01.2016 has decided as follows.

- 1. The list of safety equipments required shall be furnished by the Director (D & S) in a week time.
- 2. The Director (SCM & CP) shall finalize a centralized rate contract system for safety materials and empanelment of vendors within four months.
- 3. The Deputy Chief Engineers of Electrical Circles/ Executive Engineers of Electrical Divisions are authorised to procure necessary safety materials and equipments within their purchase limit after ensuring quality, till the process of empanelment of approved vendors is completed.
