Implementation of PTW System in Distribution Wing-Regularization of PTW System/Re constitution of existing PTW Committee- Sanctioned- Orders issued

ORDER

As per B.O (CMD) No: 2005/2014(SCKSEB/PTW System-Revised format/2014) Dated Tvpm, 23.07.2014, the Board has accorded sanction for the PTW format and guidelines for implementation in all the Electrical Sections of the Distribution Sector. Based on the requests and representations of trade unions and associations regarding PTW conditions, a revised work Authorization (WA) and Permit To Work (PTW) format was implemented w. e. f 01.04.2015 in full-fledged. Again certain issues were observed in the field and meanwhile SAFE KSEBL committee was constituted for suggesting various recommendations on safety related issues and hence the issues were presented before the committee.

Vide B.O [D(CP,SCM,G-E&S)]No: 1998/2017(CE(CAPS&S)/S/PTW/2017) Dated Tvpm 02.08.2017 a committee was formed to develop a mobile application for Work Authorization and Permit To Work system and also decided to request the IT wing develop a system of issuing work authorization and permit to Work in an electronic platform preferably smart phone compatible to serve the purpose. Further as per Office order No 1553/2019(CSC/safety/2019-20/308) Dated Tvpm 30.8.2019 four additional members are also included in the committee as per the request of IT wing for developing PTW under Basic 4Android platform which is available with IT wing without any additional cost.

The implementation of mobile application for Work Authorization and Permit To Work system—under Basic 4Android platform is on ongoing stage. Now as some of the committee members were transferred and the Power Department has submitted a proposal to Government as a part of E-safe Kerala Project including Permit To Work (PTW) system through mobile Application for safe monitoring and reducing accidents under Safe Monitor plan. Hence for smooth development of the App, the Chief safety Commissioner has recommended to include some new members and to reconstitute the committee as mentioned below for implementation of the PTW mobile application in Basic 4Android platform in a time bound manner.
